**REVISION TO
DECLARATION OF COVENANTS AND RESTRICTIONS
STONEBRIDGE
(A RESIDENTIAL SUBDIVISION)**

THE STATE OF TEXAS}

COUNTY OF BRAZOS}

By a 75% vote of the Stonebridge Homeowners Association by mail-out ballot, a resolution was passed to change Article VIII, Section 5 of the Declaration of Covenants and Restrictions as recorded in Vol. 545, Page 299 of the official records of Brazos County, to provide for the use of Security Signs to indicate Security Services providing Security for the owners property in the subdivision.

To give effect to this change, in accordance with Article IX, Section 1, 75% of the lot owners of record have approved this change in writing, as indicated by their signatures attached, as Exhibit "A"

Therefore, Article VIII, Section 5 is changed as follows, add a subparagraph (c):

(c) Any owner may display one (1) sign of not more than 1.36 square feet (15 inches by 13 inches) on any lot improved with a residential structure to indicate a security service organization which provides security for that residence. Two such signs may be placed on lots bordered by two streets.
