REVISION TO
DECLARATION OF COVENANTS AND RESTRICTIONS

STONEBRIDGE
(A RESIDENTIAL SUBDIVISION)

THE STATE OF TEXAS }

COUNTY OF BRAZOS }

By unanimous vote of the Stonebridge Homeowners Association Board of Directors at the regular meeting of November 15, 1994 at which nine of the ten members were present and voting, a resolution was passed to change Article 8 of Section IV of the Declaration of Covenants and Restrictions as recorded in Vol. 545, Page 289 of the official records of Brazos County, to permit the annual maintenance charge assessment paid by each member to be paid in two equal payments; one-half due on or before January 1 and the remaining one-half due on or before July 1 of each year.

To give effect to this change, in accordance with Article IX, Section 1, all lot owners of record have approved this change in writing, as indicated by their signature attached, as Exhibit "A".

Therefore, Article 8 of Section IV is changed to read as follows:

Section 8. The Maintenance Charge. The assessments provided for herein shall commence as to each Lot on the date fixed by the Board of Directors of the Association to be the "date of commencement" for such Lots or upon the conveyance of the Lot to an Owner, whichever is first. The first assessment shall be made for the balance of the calendar year in which it is made and shall be payable on the date of the commencement above defined. The assessments for each calendar year after the first year shall be due and payable annually to the Association in two payments; one-half on or before January 1 of each year and one-half on or before July 1 of each year. Provided, however, that, upon the purchase of his Lot (as evidenced by the date of his Deed), each Member shall be obligated to pay to the Association a pro rata part of the applicable percentage (as determined pursuant to the terms hereof) of the regular maintenance charge assessed on such Lot.

IN WITNESS WHEREOF, THE STONEBRIDGE HOMEOWNERS ASSOCIATION, has executed this REVISION acting by and through their duly authorized and empowered officers, to be effective December 31, 1994.


