By unanimous vote of the Stonebridge Homeowners Association at the Annual meeting of November 7, 1996, a resolution was passed to change Article XI, Section I of the Declaration of Covenants and Restrictions as recorded in Vol. 545, Page 289 of the official records of Brazos County, to permit changing the Covenants and Restrictions with a 75% vote of the Homeowners rather than a 100% as originally written.

To give effect to this change, in accordance with Article IX, Section I, all lot owners of record have approved this change in writing, as indicated by their signatures attached, as Exhibit "A"

Therefore, Article IX, Section I is changed as follows:

FROM: Section 1. Duration. "...the covenants and restrictions of this Declaration may be changed or terminated only by an instrument signed by the then Owners of all Lots in the Subdivision and properly recorded in the appropriate records of Brazos County, Texas."

TO: Section 1. Duration. "...the covenants and restrictions of the Declaration may be changed or terminated only by an instrument signed by the then Owners of 75% of the Lots in the Subdivision and properly recorded in the appropriate records of Brazos County, Texas."

IN WITNESS WHEREOF, THE STONEBRIDGE HOMEOWNERS ASSOCIATION, has executed the REVISION acting by and through their duly authorized and empowered officers, to be effective December 2, 1997.


