

**REVISION TO THE
DECLARATION OF COVENANTS AND RESTRICTIONS
OF
STONEBRIDGE HOMEOWNERS' ASSOCIATION
(A Residential Subdivision)**

THE STATE OF TEXAS §

COUNTY OF BRAZOS §

By more than eighty-two percent (82%) affirmative vote of the Stonebridge Homeowners Association, Inc. membership, by in person and mail-out ballots, a resolution was passed to revise a sentence in *Section 1, Duration of the Declaration of Covenants and Restrictions*, as recorded in Volume 545, Page 289 of the official records of Brazos County regarding the percentage of lots required to make any changes in the Declaration of Covenants and Restrictions.

To give effect to this revision, in accordance with *Article IX, Section 1*, more than eighty-two percent (82%) of the lot owners of record have approved this revision in writing, as indicated by their signatures on ballots that are filed at the corporate headquarters of Stonebridge Homeowners Association, Inc.

Therefore, the following sentence within *Article IX, General Provisions. Section 1. Duration*, which states:

During the last calendar year of the initial term above stated and during any such ten (10) year extension periods, the covenants and restrictions of this Declaration may be changed or terminated only by an instrument signed by the then Owners of not less than fifty-one percent (51%) of all of the Lots in the Subdivision and properly recorded in the appropriate records of Brazos County, Texas, provided no change or termination shall shorten or alter the effectiveness of these covenant and restrictions until the natural expiration of the then respective term in effect.

Is replaced with the following:

During the last calendar year of the initial term above stated and during any such ten (10) year extension periods, the covenants and restrictions of this Declaration may be changed or terminated only by an instrument signed by the then Owners of not less than sixty-seven percent (67%) of all of the Lots in the Subdivision and properly recorded in the appropriate records of Brazos County, Texas, provided no change or termination shall shorten or alter the effectiveness of these covenant and restrictions until the natural expiration of the then respective term in effect.

IN WITNESS WHEREOF, THE STONEBRIDGE HOMEOWNERS ASSOCIATION, INC. has executed this REVISION acting by and through their duly authorized and empowered officers, to be effective October 8, 2012.

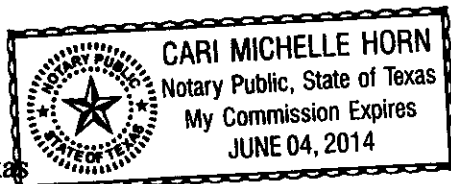
